This document, which is used in conjunction with IEC 61995-1:2025, applies to devices for the connection of luminaires (DCL) 250 V AC, 6 A intended for household and similar purposes, for the electrical connection of fixed luminaires. It defines an interface design as specified in the given standard sheets.
